This PDS may be used by master trusts or platform operators, referred to in this PDS as 'platform operators', to apply for units in the Fund, and to give to their customers (indirect investors) to provide them with Fund information they may use in making a decision about instructing the platform operator to invest in the Fund on their behalf, and to compare to other funds they may be considering. Platform operators are unitholders in the Fund; their rights differ from the rights of indirect investors, who are not unitholders.

## 1. ABOUT IPAC ASSET MANAGEMENT LIMITED

ipac is one of Australia's largest operators of multi-manager portfolios and has been helping clients achieve their financial goals and chosen lifestyle since 1983. ipac is part of the AMP Group and is the Responsible Entity for the Fund.

As Responsible Entity, ipac is responsible for the operation of the Fund under its constitution, the Corporations Act and general laws. The Responsible Entity has appointed ipac portfolio management limited (also part of the AMP Group) as the Portfolio Manager of the Fund.

The Portfolio Manager is responsible for the management and investment of the Fund's assets. It conducts extensive research into, and appoints specialist investment managers to undertake the ongoing investment of the underlying assets of the Fund. These managers range from large global firms to boutique managers. The Portfolio Manager blends these managers to construct a portfolio that aims to achieve the investment objectives. The Responsible Entity will pay the Portfolio Manager's fees from the fee it receives - it is not an additional cost to investors.

AMP Capital, also part of the AMP Group, has been appointed by the Responsible Entity, under an agreement, to provide other Fund related services, including responding to investor enquiries and the preparation of this PDS on behalf of the Responsible Entity. AMP Capital is also one of the range of investment managers which have been appointed by the Portfolio Manager to carry out the day-to-day investment of the Fund. AMP Capital is 85% owned (indirectly) by AMP Limited.

No company in the AMP Group other than the Responsible Entity is responsible for the preparation and issue of this PDS or for any statements or representations made in this PDS.

## 2. HOW THE AMP CAPITAL PREMIUM GROWTH FUND WORKS

The Fund is a high growth diversified multi-asset solution that aims to deliver high compound growth over the long term, but with lower volatility than you might expect from a typical high growth fund.

The Fund invests in a range of specialist equity, multi-asset and non-traditional investment strategies such as credit, property, infrastructure and absolute return funds.

The Fund takes a multi-manager approach where specialist investment managers, who demonstrate competitive advantages in their fields of investment, source investments for the Fund. Diversification is across regions, asset classes and managers.

### Investing in a managed investment scheme

The Fund is a managed investment scheme structured as a unit trust and registered under the Corporations Act 2001 (Cth) (Corporations Act). A managed investment scheme is where investors' money is pooled together to purchase the scheme's assets, and it is the Responsible Entity (together with the Portfolio Manager and underlying investment managers), not investors, who has day to day control of the scheme. The Fund's constitution, along with the Fund's PDS, the Corporations Act and other relevant laws, sets out the relationship between the Responsible Entity and investors.

### The value of your investment

Investors in a managed investment scheme are issued with 'units', each of which represents a share of the value of the scheme's assets. The Fund may have a number of classes of units. Investments made through this PDS relate to On-platform Class L units.

Unit prices can rise and fall on a daily basis depending on a number of factors, including the market value of the Fund's assets. Consequently, the value of your investment will vary from time to time.

**Platform operators** The value of your investment at any point in time is calculated by multiplying the number of units you hold, by the On-platform Class L unit price current at that time. Unit prices are updated regularly online at [www.ampcapital.com.au](http://www.ampcapital.com.au) and can also be obtained by contacting us.

**Indirect investors** When you invest through this PDS, the platform operator holds units on your behalf. The value of your investment at any point in time is calculated by multiplying the number of units held for you, by the unit price set by the platform operator. Your financial adviser or platform operator can provide you with the current unit price relevant to your investment in the Fund.

### Investing in the Fund

#### Who can invest?

Applications to invest in the Fund through this PDS can only be made by platform operators, investing directly in the Fund, and indirect investors, investing in the Fund through a master trust or platform, who receive the PDS (including electronically) within Australia. We can only accept applications signed and submitted from within Australia. The Responsible Entity reserves the right to refuse or reject an application.

#### How to apply

All investments are made on the basis of the PDS current at the time of contributing any investment amount. You can obtain a current PDS online at [www.ampcapital.com.au](http://www.ampcapital.com.au) or by contacting us.

**Platform operators** You will need to complete an application form and submit it with your initial investment amount of at least \$500,000. You can then make additional investments of at least \$5,000 at any time. The Responsible Entity reserves the right to accept lower investment amounts. Application forms can be obtained by contacting us on 1800 658 404.

**Indirect investors** Your financial adviser or platform operator will provide you with information about how to apply, including the form you will need to complete, minimum initial and additional investment amounts, and payment methods.

## Accessing your money

**Platform operators** Contact us in writing at any time, telling us how much you wish to withdraw and giving your account details. A balance of \$500,000 is generally required to keep your investment open.

**Indirect investors** Contact your financial adviser or platform operator for details about how to withdraw money, how your withdrawal will be paid, and the minimum withdrawal amount and account balance set by the platform operator.

## Payment times

The proceeds of your withdrawal request will usually be available within five (5) business days. However, under the Fund's constitution, payment and processing of withdrawal requests may take up to 60 days, or longer in some circumstances, including where assets cannot be realised within that time for reasons beyond the Responsible Entity's control.

## Distributions

**Platform operators** The Fund aims to pay distributions yearly after the period ending 30 June. Distributions paid are based on the income earned by the Fund and the number of units you hold at the end of the distribution period. You should be aware that although the Fund aims to pay distributions yearly, the amount of each distribution may vary or no distribution may be payable in a year. In addition, distributions may be delayed due to delayed payments of distributions from underlying alternative asset funds.

**Indirect investors** Distributions are paid directly to platform operators. You should contact your financial adviser or platform operator for details about how often distributions are paid, and the distribution payment method.

## 3. BENEFITS OF INVESTING IN THE AMP CAPITAL PREMIUM GROWTH FUND

### Significant features and benefits

#### A differentiated and diversified high growth solution

The Fund is focussed on the delivery of long-term compound growth, and operates with fewer restrictions than a traditional high growth portfolio. This means it can take advantage of long-term investment approaches and can be more opportunistic in its allocation of capital. While individual strategies adopted in the Fund may be somewhat volatile on a stand-alone basis, the combination of select strategies is designed to produce a more diversified portfolio than that delivered by a traditional high growth portfolio (which generally comprise 100% equities).

#### A more comfortable high growth journey

With more diverse sources of return, the variability of the Fund's short-term returns may be reduced. With less reliance on traditional share portfolios in Australia and offshore, the Fund aims to provide investors with more stable performance than a typical high growth portfolio. It is worth noting that, in the short term, returns relative to a traditional high growth portfolio will tend to lag when Australian shares are performing particularly well but outperform when Australian shares are relatively weaker.

## 4. RISKS OF MANAGED INVESTMENT SCHEMES

### All investments carry risk

Assets with the highest long term returns may also carry the highest level of short term risk, particularly if you do not hold your investment for the minimum suggested investment timeframe. Additionally, different investment strategies may carry different levels of risk, depending on the assets in which a fund invests.

When you invest in a Fund, you should be aware that:

- returns are not guaranteed – future returns may differ from past returns, and the level of returns may vary, and
- the value of your investment may vary, and there may be the risk of loss of invested capital.

The value of your investment may also be affected by the Fund-specific risks noted below and by other risks or external factors such as the state of the Australian and world economies, consumer confidence and changes in laws and regulations including tax laws and government policies relating to managed investment schemes.

Other factors such as your age, the length of time you intend to hold your investment, other investments you may hold, and your personal risk tolerance will affect the levels of risk for you as an investor. As the risks noted in this section do not take factors such as these into account, you should consider obtaining appropriate financial advice before making a decision about investing or reinvesting in the Fund.

### Risks specific to the Fund

Risks specific to the Fund may include or be associated with:

- **share market investments** – the value of the Fund's investment in listed securities may decrease as a result of adverse share market movements.
- **international investments** – including losses related to currency exchange rates, hedging, and changes in the state of the Australian and world economies.
- **alternative assets** – traditional risks such as credit and liquidity risk can be magnified for alternative assets.
- **asset allocation** – the Fund's asset allocation strategy does not guarantee positive investment performance at all stages of the investment cycle.
- **counterparty or default risk** – substantial losses can be incurred if a counterparty fails to deliver on its contractual obligations or experiences financial difficulties.

- **derivatives** – the use of derivatives may magnify any losses incurred.
- **investment management** – there is a risk that the investment manager will not perform to expectation or factors such as changes to the investment team or a change of investment manager may affect the Fund's performance.
- **liquidity** – assets subject to liquidity risk may be difficult to trade and it may take longer for their full value to be realised, and in circumstances where the Fund's portfolio ceases to be 'liquid' for Corporations Act purposes, there may be significant delays or a freeze on withdrawal requests.
- **securities lending** – although engaging in securities lending by underlying funds in which the Fund invests may benefit the Fund by providing increased returns, there is a risk of capital loss.

## 5. HOW WE INVEST YOUR MONEY

### The Fund

The Fund is a registered managed investment scheme which invests in a diversified mix of assets, including exposure to non-traditional investments.

The Fund may be suitable for investors seeking high capital growth over the long term.

The Portfolio Manager aims to manage asset allocations within the asset allocation ranges. However, in certain circumstances, the Portfolio Manager may manage actual allocations outside of the asset allocation ranges. Such circumstances would include where the Fund or underlying funds are closed for new applications or withdrawals, during changes to the product structure, asset allocation or manager line-up, or in certain market conditions. The Portfolio Manager will not deviate outside the asset allocation ranges to pursue investment opportunities based on short-term expectations.

The Portfolio Manager regularly reviews the Fund's target asset mix and can re-balance the Fund within the strategic ranges, where necessary to suit market conditions.

### Investment return objective

The Fund aims to provide high growth over the long term through the capital growth of its underlying investments.

### Suggested minimum investment timeframe

5 years

The Fund's risk band and risk label are based on an estimation that the number of negative annual returns over any 20 year period would be within the range of 3 to less than 4. ## 6. FEES AND COSTS

### DID YOU KNOW?

Small differences in both investment performance and fees and costs can have a substantial impact on your long term returns. For example, total annual fees and costs of 2% of your investment balance rather than 1% could reduce your final return by up to 20% over a 30 year period (for example, reduce it from \$100,000 to \$80,000).

You should consider whether features such as superior investment performance or the provision of better member services justify higher fees and costs. You may be able to negotiate to pay lower contribution fees and management costs where applicable. Ask the fund or your financial adviser.

## Summary of fees

### Overview of fees and costs

Table 1 provides an overview of the costs of acquiring units in the Fund, and the fees and costs charged in relation to your investment. These fees and costs may be deducted from your money, from the returns on your investment or from the assets of the managed investment scheme as a whole. For the Fund, these fees and costs are paid out of the Fund's assets, and are reflected in the unit price. You can use this information to compare the Fund's fees and costs with those of other funds.

Unless otherwise stated, the fees and costs shown in this section are inclusive of Goods and Services Tax (GST) and any applicable stamp duty, less Reduced Input Tax Credits (RITCs) or other input tax credits claimable.

Unless otherwise specified, all dollar amounts are Australian dollars.

### Important

Fee amounts shown in this PDS are the fees and costs the Responsible Entity charges platform operators investing through this PDS. If you are an indirect investor, please contact your financial adviser or platform operator for details of the fee amounts relating to your investment in the Fund.

Fees may be payable to your financial adviser, these fees are additional to the fees noted in Table 1 (refer to the Statement of Advice provided by your adviser).

### Changes to fees

The Responsible Entity may change the fees noted in this PDS at its discretion and without the consent of platform operators or indirect investors. For example, fees may be increased where increased charges are incurred due to changes to legislation, where increased costs are incurred, if there are significant changes to economic conditions, or if third parties impose or increase processing charges. However, we will give platform operators 30 days' written notice of any intention of the Responsible Entity to increase the existing fees or introduce performance fees or contribution or withdrawal fees.

### Example of annual fees and costs

Table 2 gives an example of how the fees and costs in the Fund can affect your investment over a one year period. You should use this table to compare this product with other managed investment products. The fees and costs shown in this table are an example only and are not additional to the fees and costs described in Table 1.

### Cooling off rights

**Platform operators** Cooling off rights do not apply in relation to an investment in the Fund.

**Indirect investors** Cooling off rights do not apply under this PDS. Your financial adviser or platform operator can provide you with the conditions, if any, that apply to returning your investment within the cooling off period set by the platform operator.

### Complaints procedure

**Platform operators** AMP Capital and the Responsible Entity follow an established procedure to deal with complaints. We are committed to providing you with a high level of service, but sometimes things go wrong. If this happens, we will help you resolve the issue.
